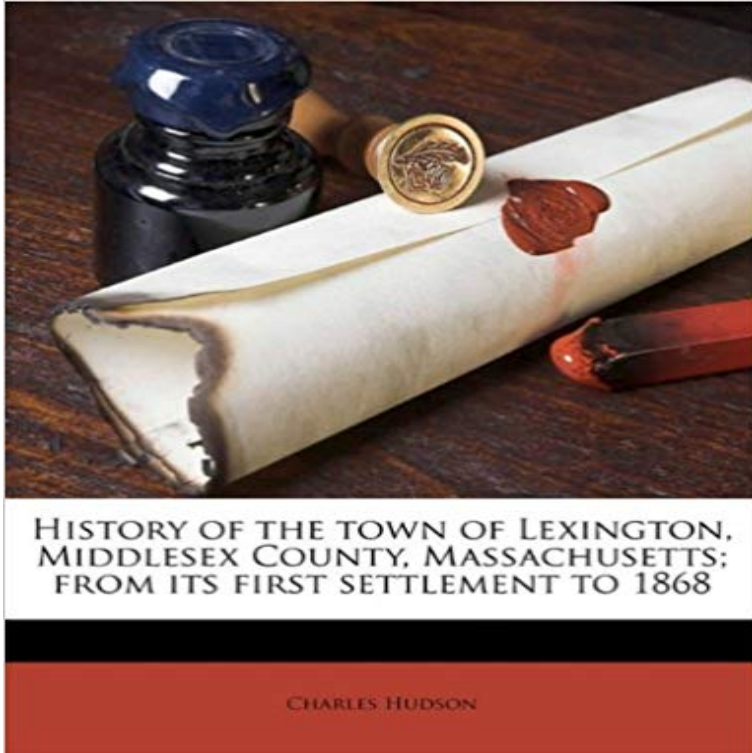


History of the town of Lexington, Middlesex County, Massachusetts; from its first settlement to 1868 Volume 2
